The Executive Committee of Environmental Contractors Management Association Limited ('the Association') submits its report together with the audited financial statements for the year ended 31 March 2023.

PRINCIPAL ACTIVITIES

The Association runs as a non-profit making company and its principal activities during the year included, inter alia, to promote the interests and general welfare of the environmental contractors management industry and other relating industries; to promote the professional image and competence of its members; to establish and maintain high standards of competence, knowledge and performance on hygiene cleaning, material recycling & recovery and related circular economic activities; and to enhance/foster working relationships and/or partnerships with all relevant Government departments/ those engaged in the industry.

In accordance with Part A Mandatory Articles Article 4 of the Association's Articles of Association, no fund should be paid or transferred directly or indirectly, by way of dividend, bonus or otherwise howsoever by way of profit, to the members of the Association.

SHARE CAPITAL

The Association is a company limited by guarantee without a share capital.

In accordance with Part B Other Articles (Part 2 Division 3)- Articles 20 (1) and (2) of the Association's Articles of Association, the first Executive Eommittee members shall remain in office until the second annual general meeting. Executive Eommittee members shall be elected at the second annual general meeting and at each and every alternate annual general meeting thereafter.

In accordance with Part B Other Articles (Part 2 Division 3)- Article 20 (3) of the Association's Articles of Association, all of the Executive Committee members shall retire from office at the next alternate annual general meeting from that in which they were elected so that their terms of office would be about two years but being eligible, offer themselves for re-election.

MANAGEMENT CONTRACT

Save as otherwise disclosed in the financial statements, at no time during the year the Association had entered into a management contract by which a person undertakes the management and administration of the whole or any substantial part of any business of the Association. In accordance with Part B Other Articles (Part 2 Division 3)- Article 25 of the Association's Articles of Association, all the Executive Committee members shall serve without receiving remuneration and shall not become the salaried staff of the Association.

BUSINESS REVIEW

The Association falls within the reporting exemption and is exempted from preparing business review in this report as required by Section 388(3) and Schedule 5 of the Hong Kong Companies Ordinance (Cap. 622).
